Sealed "Bid Auction Form" must be properly filled out and sent to IOM Office Reception by the address; Birlik Mahallesi Şehit Kurbanı Akboğa Sokak No: 24 Çankaya, Ankara, Turkey (please handover to Mrs Julide ERCIN). Submission deadline is no later than the **03:00 pm on Friday, 26th of January 2018**. Soon after the deadline is over, envelops will be unfolded and the bids will be evaluated. Vehicle shall be sold to the highest bidder. Successful bidder will be notified by telephone/e-mail as applicable. Successful bidder will have 2 days to sign the IOM Deed of Sale and pay IOM Ankara (Finance Unit) the down payment (50% of the total amount) then MFA paperwork may proceed. Once MFA approved the ownership transfer, the buyer shall pay IOM the remainder of the amount (50%) and only by then can physically receive the vehicle.

NOTE: the following rules apply to this selling:

1. The vehicle shall be sold to the highest bidder and accepted by him/her on an "as-is" basis. No guarantee or warranty are given or implied. IOM wouldn't assume any responsibility or provide a guarantee for damages or whatever faults, that might occur after handing over the vehicle. Sale is final – no return, no refund and no exchange are permitted.
2. The vehicle has a diplomatic status and CD plate number. Any and all applicable taxes and duties are entirely the responsibility of the buyer to settle with the relevant government entities. IOM shall only facilitate the ownership transfer with MFA.
3. IOM reserves the right to reject any bid that is not considered to be adequate with the value of the vehicle, or to reject any bid where there is evidence/indication of connivance, collusion or bribery.
4. Payment must be made in USD by bank transfer to IOM Ankara financial account.
